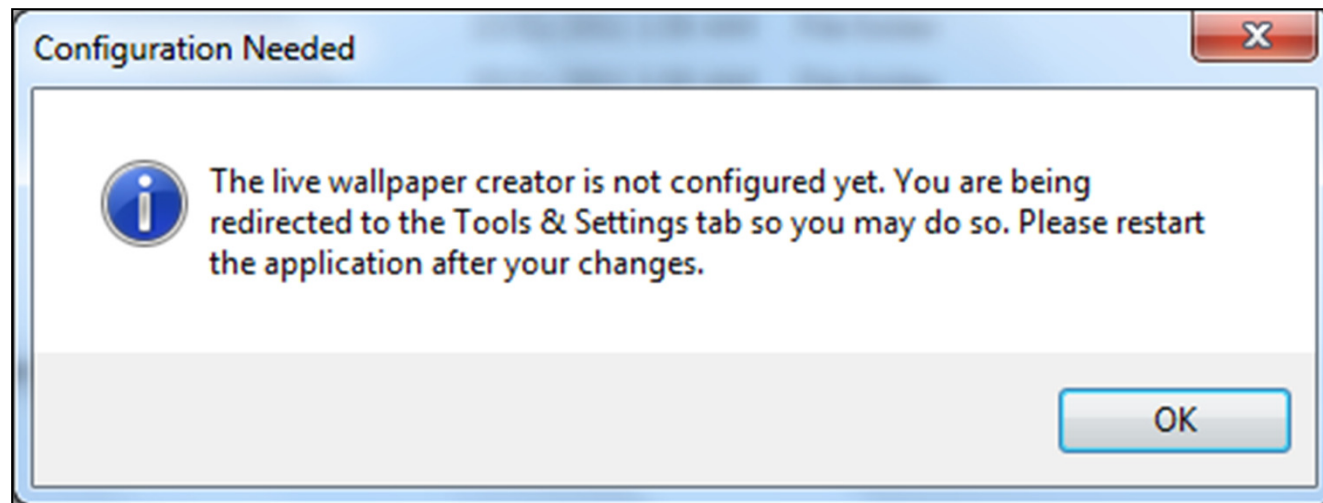

# Starting the Live Wallpaper (LWP) Creator

- Navigate to the LWP Creator folder and run [LiveWallpaperCreator](#).
- If this is the first time you are configuring the LWP Creator, you will see a message telling you to configure the program.
- Click [OK](#) and wait for the LWP Creator to appear.



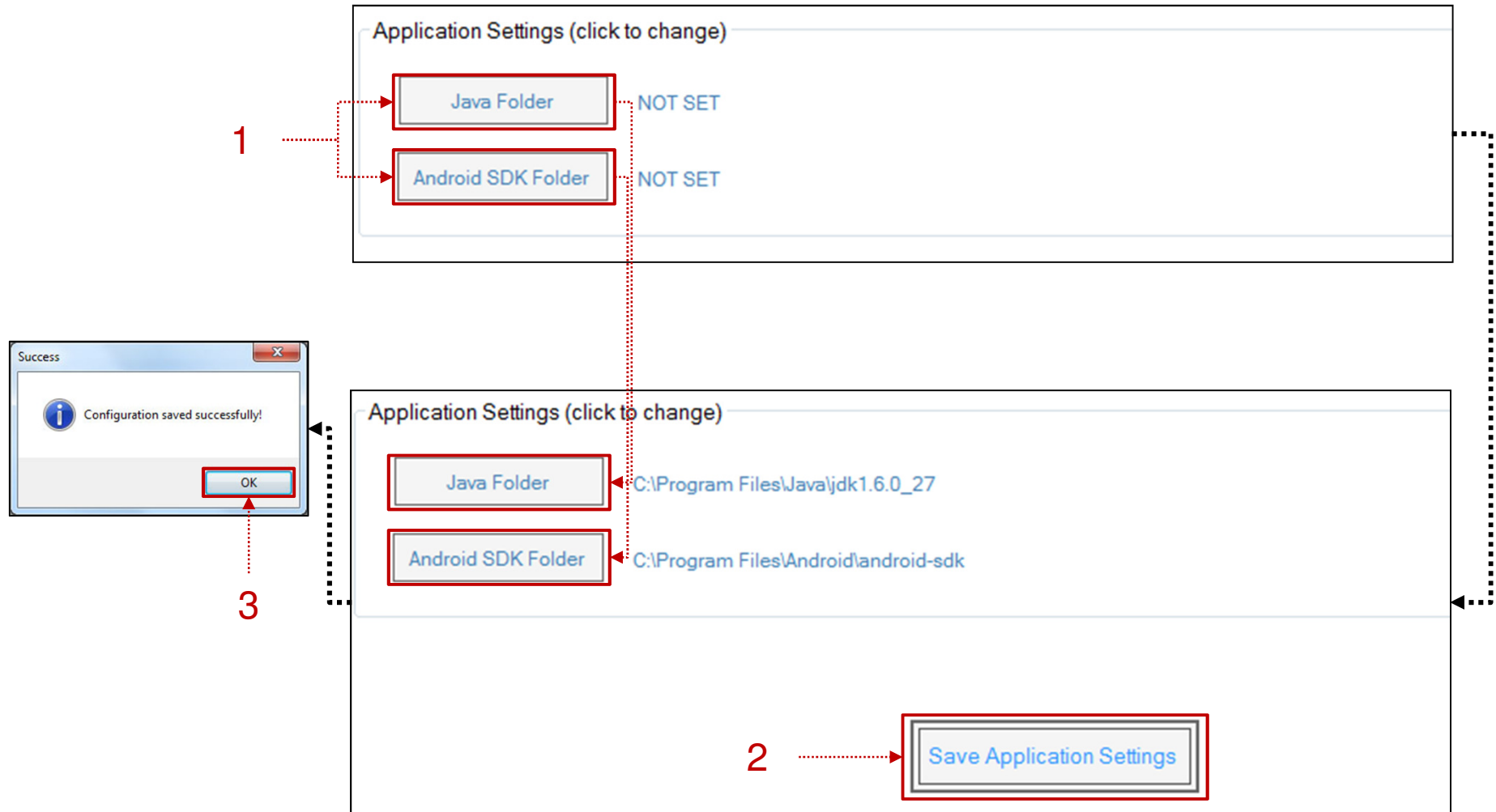
# Configuring Application Settings

- You will now see the **Tools & Settings** tab.
- At the bottom, you will see **Application Settings** that has 2 fields:
  1. **Java folder.**
  2. **Android SDK folder.**
- By default, all fields are set to **NOT SET**.
- You will need to click on each button and locate the corresponding resources on your computer.

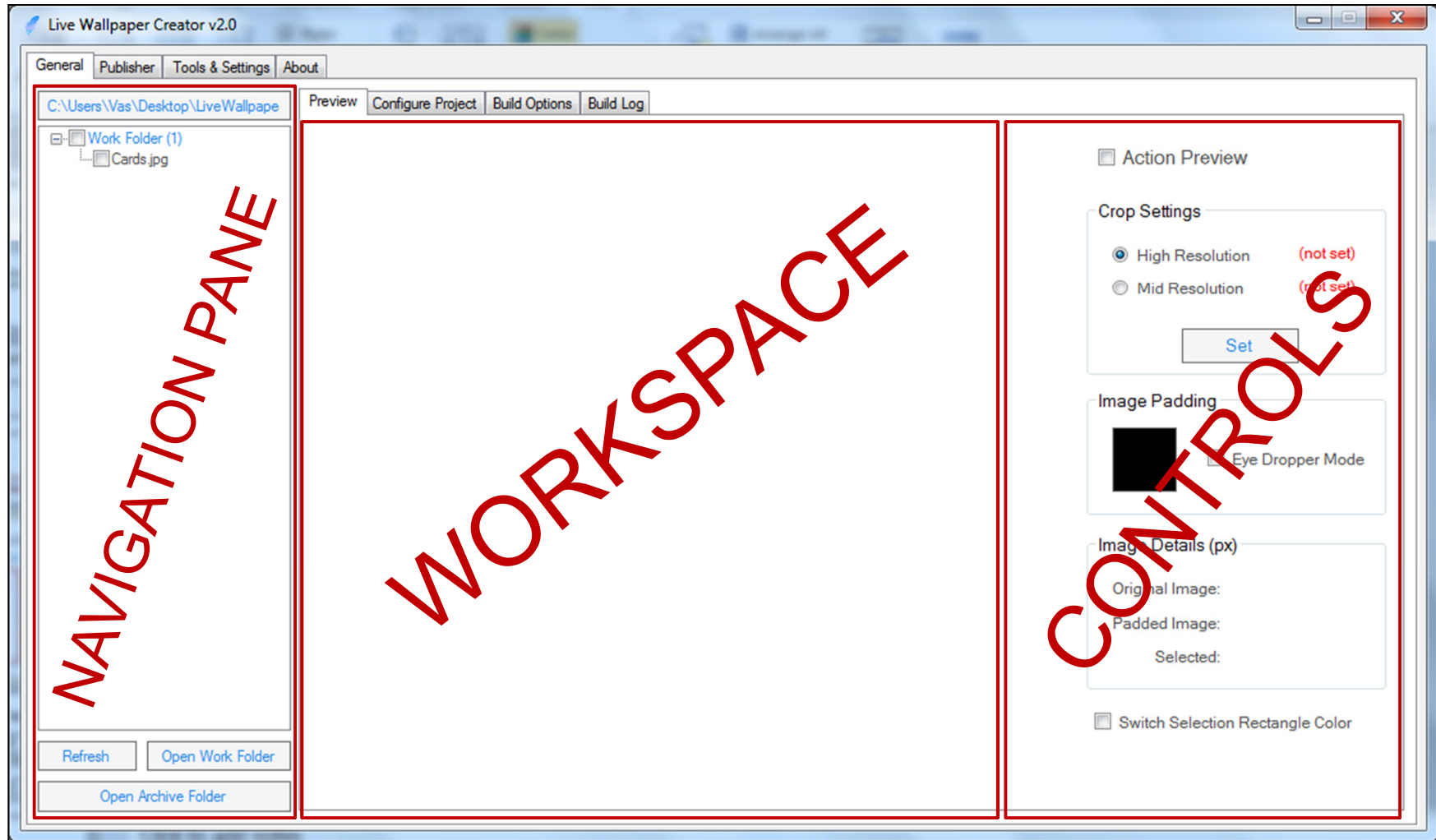
# Configuring Application Settings (cont.)

- Set each path by clicking on its corresponding button.
- You should know the locations of both settings from installing the components from the first guide.
- Once you have set the parameters, click **Save Application Settings** and **restart** LWP Creator (pics below).

# Setting up the Configuration tab (cont.)



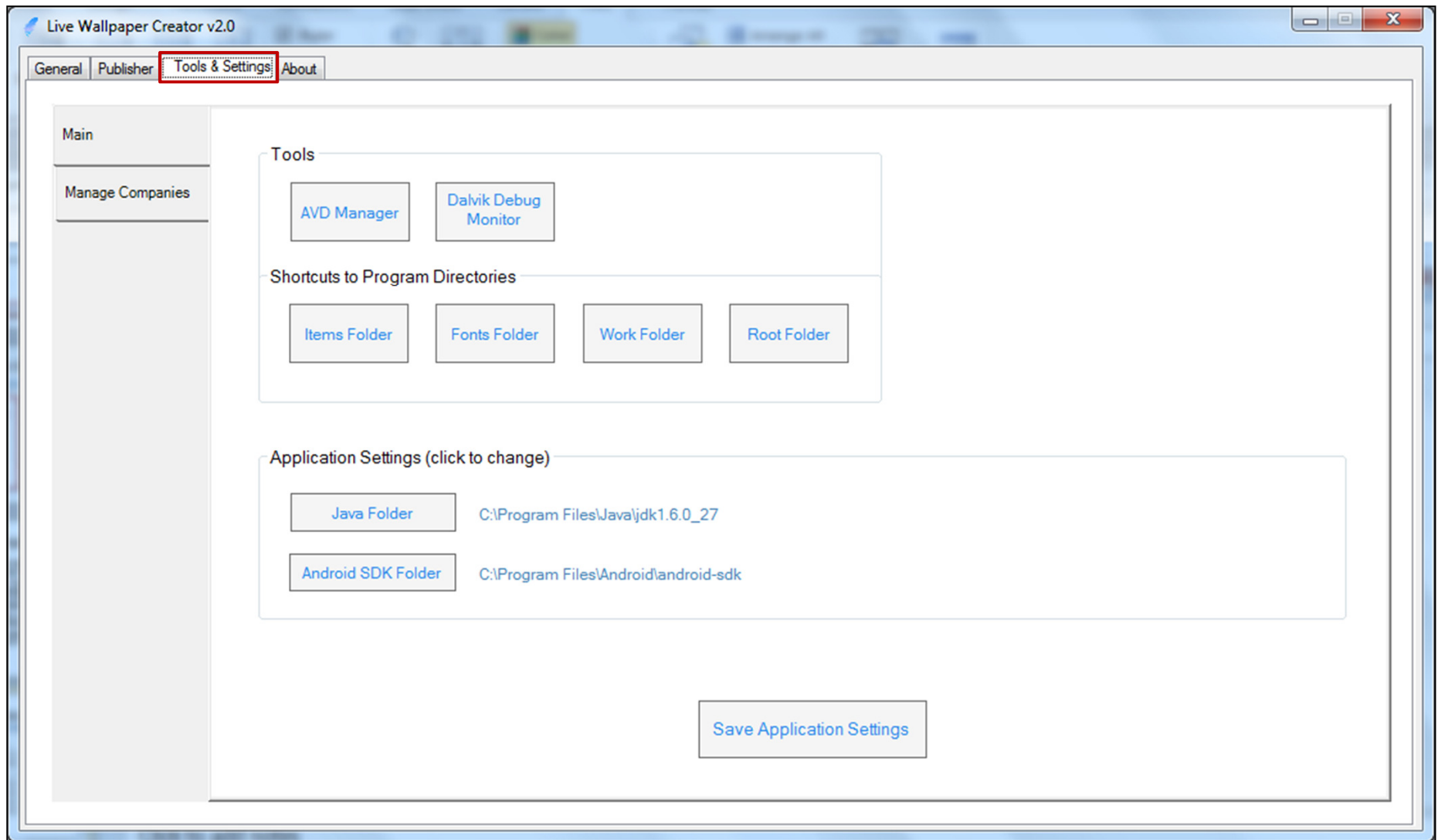
# LWP Creator Main Screen



# Tools and Settings Tab

- The **Tools and Settings** tab has a number of useful tools and shortcuts such as:
  1. **Company Management** tab. (This will allow you to create companies, manage application description text, and create or import keys that you will use to sign your applications).
  2. **Android Tools**. (These will help you test your live wallpapers and take screenshots).
  3. **Shortcuts to Program Directories**. (These will help you access different parts of the LWP Creator folder).

# Company Management

- Before you can start creating live wallpapers, you have to create a new company profile.
- A company profile will store and associate your publishing name, application description and a key.
- All applications MUST be signed with a key before they can be published or installed on a device.
- You can create a new private key, or import an existing key while creating a company profile.

- To create a company profile, go to **Manage Companies** sub-tab, click **Add** and fill out the required fields.
- When you create your own key, use your own information. For this tutorial, we will write **demonstration** in all the fields.
- To import your own key, choose **Import Existing** and click **Select Key File**. In the new window, find the key you are trying to import and click **Open**.
- Once you have entered all the information, click **Add Company**.
- You can use the **%APPNAME%** variable in the **Description** text field to reference your application name.
- Most control elements in LWP Creator have help tooltips that appear if you hover over a control. If you are unsure what something means, try hovering over it with your mouse pointer!
